Interview with above (owner and mgr of Richfield service station and Jack Davies Garage) who employed Sirhan Sirhan from Sept 28, 1964 (when Davies purchased the station) to June 7, 1965. Davies purchased the station from a Clarence Copping - 2747 Morningside, Pasadena. Copping hired Sirhan approx. (6) six months prior to Davies buying the station.

Davies recalls that Sirhan was a quiet, educated boy. Sirhan had no friends ~~that~~ ~~that~~ ~~that~~ that would visit him at the station but that he, Sirhan, was very interested and bet heavy on horses ^{at} Santa Anita. Sirhan quit the job because he and a second co-worker got into a heated argument over Sirhan's dominant personality. (C-Carol Lambrecht)

Approx (3) three months ago Sirhan came into Davies' station with his DeSoto to be lubed. Davies told Sirhan to go ahead and use the equipment. Davies then helped Sirhan re-tune the car as Sirhan stated it hadn't been used in 3 or 4 months. Sirhan also stated that the car was not registered for '68 and that the plates were from his brothers car.
