Above appears to be two different guns on Date Out problems I see: Moser 6167 SID takes H53725 out 6-5-68 + Moser returns gun H53725 same date. But Wolfer takes out a rev + spent (?), on 6-5-68 but no gun ID # given. Then - "All Contents trans to SUS 8-24-68" and marked "Confidential SUS" How can this be? Because H53725 was under seal with LACGT until Loring hearing (May '69). And remember LACGT did not record the gun's serial number into the record. So what was the gun # that entered into evidence 6-7-68 with the LAC gun? Maybe H53725
