On April 4, 1969, Henry Ronald Ramistella, also known as Frank Rumma, also Donneraumma, stated he was employed by Bert C. Altfilisch (phonetic), owner of Granja Vista Del Rio Ranch, as a horse trainer for two years ending early 1968. Ramistella states he is barred from tracks and worked for Altfilisch under alias for this reason.

Sirhan Sirhan, also known as Sol, worked for Ramistella as exercise boy and jockey traines for one and one-half years. Sirhan quit after being rejected by R.L. "Bob" Wheeler as jockey. Wheeler known to Altfilisch.

Ramistella witnessed Sirhan fall from a horse in incident publicized by newspapers. States Sirhan not injured in fall, treated in hospital and released. Sirhan behaved no differently following fall.

Sirhan argued politics "COMMUNISM" with two Hungarians; JOHN (Last name unknown) only name available.

Altfilisch may be able to furnish names of Hungarians.

No local record or wants on the above name or AKA. Security check with a MUS Carpender through the Calif. Racing Assoc. shows that the subject has prior narcotic and petty larseny arrests in New York. He was denied a stable license in Feb. 1960 and later had his license suspended in New Jersey.

PHONE

In 1966 he applied for a stable license at Santa Anita under the name of Frank Donneraumma. After receiving a license the association found out Donneraummas' real name was Rainistella and again suspended him.

In Sept. of 1967, Rainistella attempted to buy a 1962 Lin. Cont., lic. #GHH 895 financing it through Bank of Am. erica.

After the subject took possession of the veh. he made no more payments for 8 months. The veh. was later located on a ranch in Corona and repossessed.

The subject's last address (1967) was at 13200 Citrus, Corona living with a Bert Altfillisch who is a horse owner and poss. related to Rainistella through a marriage in the family. Ph# (714) 737-1961

Bert Altfillisch was contacted and stated that Rainistella had hired Sirhan Sirhan in March of 1967 as an exercise boy. A few months after this, Rainistella became a heavy drinker and was dropped from the payroll. Rainistella hasn't been seen by Altfillisch for approx. one (1) year.

Altfillisch stated that the FBI had been to his ranch and checked the payroll records of both Rainistella and Sirhan. Sirhan worked on the ranch up to the early part of 1968 then left.

A check with CII shows Donneraumma to have a two page sheet, his latest in July of 1967 for 23102 and driving without a driver's license. He received three (3) years probation and a \$250 fine (LASO #A89976). His last address was 3231 Hamner, Norco. This address was checked through the Phone Company and the subject no longer lives there.
